Webinar on Entrepreneurship and Family Business





WORKSHOP ON

'RESEARCH PROPOSAL AND REPORT WRITING

RAPPORTEUR'S REPORT

01/12/2020

A workshop was organised by the Department of Education, Salesian College Siliguri on the theme 'Research Proposal and Report writing' on 1st December 2020 over Google meet platform and YouTube. Around 50 participants were present for the workshop. The session began approximately at 12:10 pm and extended up to 2:15pm. The resource person for the session was Dr. Savita Mishra, Principal of Vidyasagar college of Education Phansidewa, West Bengal. The workshop began with a short introduction of the esteemed resource person by Ms. Ranita Chakrabortty. This was followed by the welcome address by Fr. (Prof.) George Thadathil, Principal, Salesian College.

Before the presentation, a brief framework was provided with respect to the research and process of writing, followed by Dr. Savita Mishra's discussion on how to identify the research problem. She also mentioned the area on which one is willing to do the research. In this context the resource person drew the attention of participants on how to write a research proposal. She discussed on the structure of a research proposal, elaborating on the different aspects of the proposal. Speaking of the process in research writing, Dr. Mishra shared her experience while writing her Ph.D. thesis. While elaborating on the steps of the research proposal the presentation mainly focused on the introduction, literature review, rationale of the study, statement of the problem, objectives of the study, hypothesis of the study, scope and delimitation, methodology, sample, tools, techniques of data analysis. She also discussed about importance of abstract and what should be taken into consideration while writing an abstract.

In conclusion, Dr. Savita Mishra emphasised on the different styles of reference writing such as those of APA, Chicago and the MLA referencing style. Apart from proper referencing, the resource person also drew the attention of the participants to the need to avoid plagiarism at all cost while preparing the research report. In this regard, Dr. Mishra presented an in detailed discussion on the various ways to avoid plagiarism and the need for proofreading before submitting the final research report.

Following the presentation, there was an activity session in which the participants were asked to prepare a research proposal on any topic of their choice. During the course of this activity session, many queries were raised by the participants to the resource person regarding the various aspects of the research process. Towards the end of the activity session, the participants presented their research proposal. This was followed by the closing remark by Fr (Dr) George Chempakathinal, Vice Principal, Arts/Humanities Stream, Salesian College Siliguri. The workshop ended with a vote of the thanks that was presented by Ms. Priya Topno, Assistant Professor, Department of Education, Salesian College Siliguri.


Thus, on the whole the webinar was a huge success.






Figure 1: Rating of Plenary 1




Figure 2: Rating of Plenary 2




Figure 3: Rating of Plenary 3




Figure 4: Rating of Plenary 4




Figure 5: Rating of Plenary 5




Figure 6: Take Away from Seminar

MCJH FACTSHALA WORKSHOP

January 2020, Siliguri: The Department of Mass Communication and Journalism organized a workshop on the topic 'a fight against misinformation and empowering citizens through news and information literacy' from Factshala India.

The speaker for the event was Dr. Shourini Banerjee, certified professional trainer (FACTSHALA, news and information literacy initiative by DataLEADS with support from google.org) and academician, Dr. Banerjee has completed her PhD research on "gender and masculinity in television commercials-a critical study', she has also published and presented multiple papers in national and international conferences.

The event commenced with an opening speech by Fr. (Dr.) George Thadathil (Principal, Salesian College), father spoke about the importance of differentiating between news that is derived and news that is concocted, he said "one's proposition must not harm one's right to be".

Therafter, Dr. Banerjee began her talk with how one can develop independent thinking and verify content by fact checking. "Information empowers but over load cripples' expressed Dr. Banerjee. The session focused on the sources of information, why good information is important and how it affects socio-economic and political decisions.

Dr. Banerjee then continued on the dangers of misinformation, bias, manipulation on social media and the effects of being 'confined in a box of content'. She elaborated on filter bubbles, echo chamber and types of propaganda that exists in the current world. Dr. Banerjee concluded her speech by highlighting the importance of critical thinking and ways to improve it with multiple interactive exercises followed by a question and answer session.

The session then concluded leaving the participants with new perspective on news and information.

Trends in Science and Technology - TIST 2021



A one day National Conference on "Trends in Science and Technology 2021" was organised by the Science Departments of Salesian College, Siliguri campus, on 28th February 2021. It was held in blended mode where dignitaries and some participants attended online and organisers and some participants attended offline. It began with the lighting of the lamp by the Fr. (Dr.) George Thadathil, Rector and Principal, Salesian College, Dr. S C Das, Rtd. Professor of Physics, Mr. Dhirodatta Subba Dean of Science, Mr. Subhajit Paul, Head, Department of Mathematics and Mr. Prajwal Chettri, Head, Department of Physics. Dr. S C Das conducted welcoming ceremony and outlined the background of the Conference and mentioned that it aimed at providing a platform for exchanging views on latest trends in the realm of Science and Technology, knowledge sharing by domain experts and research scholars, and also to establish connections with institutions of National importance with the people of this region. He laid emphasis on the fact that we were observing the National Science Day.

Father (Dr.) George Thadathil, Principal of the College, continued with welcoming all and then moved to introduction of the program to all who were present and threw coherent light on the relevance of organising such conference in the context of the current scenario of higher education in India, despite the pandemic situation throughout the world. He emphasised the importance technology in higher education and the need to keep up with times, especially in regard to the major changes being brought in with reference to the new National

Education Policy. After this, the keynote speaker – Dr. Arnab Chakraborty, Associate Professor, Applied Statistics Unit, Indian Statistical Institute, Kolkata, was introduced by Mr. Subhajit Paul, Head, Department of Mathematics, Siliguri Campus.

Dr. Arnab Chakraborty delivered his "National Science Day" talk on this year's theme "Future of Science Technology and Innovation: Impacts on Education, Skills, and Work". Starting with four fundamental observations:

- (a) the country is technologically impoverished
- (b) our country was great Aryabhatta, Brahmagupta, Madhavacharya and the invention of *Calculus*
- (c) our country is great Nobel prize winning scientists like Satyen Bose, Jagdish Chandra Bose, Ramanujan, C V Raman and others
- (d) booming of higher education institutions

Dr. Chakraborty went on to present his own take on the state of things. First thing that he was critical about was the mercenary attitude of his countrymen in matters related to Science and Technology – that the people involved, in general, across all institutions, were doing work for financial benefits, for publishing in reputed journals and because government has that project funded, and not for the love of it. He went on to say that our people were good at utilising apps, technologies developed by others but poor in creating original products, be they software or others. He also mentioned inadequacy of infrastructure support in institutions to support research. He further mentioned people's attitude of running after high end advanced research areas in science and technology whereas research and development in simple areas could have made more sense due to its applicability in people's daily lives. He concluded with the opinion that people need to be more innovative and more practical minded and ready to put in more effort in originality and not let others exploit our weaknesses.

There was interactive session after the keynote talk. Fr. George Thadathil, our Principal, expressed his agreement on the views shared by the speaker. He, however, mentioned that all was not lost by giving the example of own institution where we developed our own Enterprise Resource Planning software, after having experimented with a Software company for such system for three years. This was followed by a short intermission before the next session.

The first technical session was chaired by Mr. Bicky Sharma, Head, Department of Economics. He introduced the plenary speaker Dr. Mona Chettri, post-doctoral research fellow, Australia-India Institute, University of Western Australia. Dr. Mona's talk was titled "Gender, migration and the precarious labour in the Eastern Himalayan region". She started by acknowledging that she was the only speaker from the Social Science and she thanked Fr. Principal and the organisers for extending the invitation to her. She mentioned that she was from Sikkim and that her research studies are on Sikkim and Darjeeling Hills.

Her focus of the talk was on young, mobile women who are working in the informal sector - primarily in manufacturing and servicing sector, and situated in Sikkim. Key points of her talks were:

- Emergence of new labouring class as a result of globalisation and liberalisation
- Intersections of gendered constructions of labour and liberalisation
- The increasing precarity and instability of employment in the eastern Himalaya



Gender, Migration and Precarious <u>Labour</u> in the eastern Himalaya



Majority of these women come from educationally or economically disadvantaged families. They are working in factories, shops, malls, restaurants and cafes – low paying jobs and having no safety nets because of the informal employment sector. This sector is thriving due to government incentives, and globalisation and changing consumption patterns of people and business owners trying to increase sales. This is causing significant migration of female population from rural to urban areas. Most of them are first generation employees in this sector. They are at increased risk of exploitation. So, on the one hand they are getting employment; on the other hand, they are being exploited too. She left with the question of finding and developing safety nets for this group of people. Her talk ended with a short question and answer session.

The next presenter was Ms. Manasi Debnath, faculty, Department of Geography, Salesian College. Her presentation was on "Reconstruction of Paleoclimate with reference to Cryosphere dynamics in the Changme Khanpu valley, Sikkim".





Reconstruction of Palaeoclimate

She started by explaining paleoclimate as climatology prior to the instrumental records of temperature, precipitation and other weather phenomena. She mentioned that such studies have been done for other parts of the Himalayas like Garhwal, Karakoram, Nepal and south-east China. It is important to know the information for future modelling as some civilisations have been lost in the past due to abrupt climatic changes. This leads us to the glaciers in the Himalayas. In Sikkim, glaciers are retreating at fast rates. Her study was about reconstruction of a model of past glacier landform within the Changme-



Khangpu valley and identification and assessment of paleoclimate changes within the Quartenary period. She led us through the analysis of her study where she explained the chronological events that took place in the past in the formation and movement of this glacier and corroborated the findings with studies done elsewhere. She also explained that her data came from Sentinel 2A, LANDSAT 8-OLI, SRTM-DEM and field survey. She also explained the methodology used in the investigation. Due to paucity of time, question-answer session was skipped and program moved to the next presentation.

The next speaker was Dr. Protip Basu from Siliguri College. The topic was "Amalgamation of Sequence Bioinformatics and structural Bioinformatics – teaching Bioinformatics to lay persons and non-biologists". He spoke on how to bring about changes in methods of teaching that would help students reach the right place quickly. He took, for example, the ncbi site which is the go-to place for all students of biology. However, getting to the right place is not easy.

He mentioned that due to the pandemic situation, our dependence on technology is increasing and we are having to continue education in the new normal. Key points of his talk were:

- Intelligent use of search engines. For example, in case of NCBI portal, students can narrow down the search by choosing the right database, followed by using key word combinations in proper manner, so the search result list is narrow and specific. Moreover, the portal provides some colour coding in the result pages and the balloon/context sensitive help feature is of great help. Similarly, searching google also can be made smarter by making use of the advanced features and the choice of right combinations of key words.
- Teachers to make the presentation by making use of animated graphics, colour schemes with explanations.
- Search results to be stored locally and BLAST (Basic Local Alignment Search Tool) to be applied.
- His research on structures of protein (PDB Protein Data Bank portal), crystal structure of Human Argonaut (4OLA).

This was followed by lunch break.

The second technical session was chaired by Dr. Prajwal Chettri, Head, Department of Physics. He introduced the plenary speaker Prof. Somendra Mohan Bhattacharjee, Head of Department of Physics, Ashoka University. His talk was titled "Emergent phenomena: more is different".

Prof. Bhattacharjee started from Paul Adrian Maurice Dirac's 1929 controversial statement: "quantum mechanics is now almost complete ... [and] the underlying physical laws necessary for the mathematical theory of a large part of physics and the whole of chemistry are thus completely known", although he admitted that "the difficulty is only that the exact application of these laws leads to equations much too complicated to be soluble."

This sweeping statement was due to the success of Quantum Mechanics which overpowered everything in those days, and influenced the works

of Physicists for decades. They forgot how science started – through observations and measurements. The laws of motion and gravitation discovered much earlier by Kepler and Newton could explain planetary motions well, and they had nothing to do with Quantum Mechanics. In truth, what works at the micro scale, in the constituents, changes / emerges into something quite different at macro scale. He gave a number of illustrations to show emergent behaviour – traffic jam with cars on the road, matter changing from solid to liquid to gas, probability distribution of gas molecules in terms of speed/energy [Maxwell-Boltzmann distribution] giving rise to Boyle's law, Charles' Law. So, reasoning in the same way, Newton's law is really an emergent phenomena of quantum mechanics laws. In the same way collections of cars each obeying Newton's laws of motion, ends up behaving in a different way at traffic jams – involving probabilistic and statistical factors. This was what was termed "more is different" by a Nobel laureate Philip W. Anderson of Princeton University.

The next presenter was Mr. Bikramjit Chandra, faculty, Department of Physics, Salesian College. His presentation was titled "Detection of Phosphene in the Venusian atmosphere – A Discussion".

There was a paper published by Jane S. Greaves and associates in September 2020 *titled "Phosphine gas in the clod decks of Venus"*. This was a paper on Radio and Planetary Astronomy. It created quite a bit of excitement among the scientists who are hopeful of discovering signs of life in other planets. It claimed that they used two radio telescopes JCMT and ALMA and detected phosphine, a bio signature gas, at 56 km height from the surface of Venus. Their conclusion was based on 5 year data from the telescopes. Existence of life forms was a conjecture from the 70's and some papers were written in 2017 and 2020 prior to the current paper, where it was suggested that between 40 – 70 km from the surface, conditions were favourable.

Comparing the absorption signature of phosphine with the sample data analysis, they found a similarity and concluded that this could be phosphine in Venus' atmosphere. And they tried to explain how the gas could have come into existence on the basis of 75 different chemical reactions that are possible; but they found that the rate of destruction of phosphine was much higher than the rate of formation.

Critics of this theory asked the question: "how do you know you are not detecting sulphur dioxide?" Greaves and associates defended their claim.


However, in April this year, Andrew P. Linkowski and associates published a paper "Claimed detection of PH₃ is consistent with SO₂". They did the modelling of both phosphine and sulphur dioxide in the Venusian atmosphere, and found that the signature of SO₂ is twice as strong as PH₃, and that for them to be detected,



they should exist at 80 km above the surface and not 56 km. This study finally put to rest the conjecture of phosphine's existence in Venusian atmosphere.

The next presenter was Mr. Alok Barua, student, BCA third semester. His topic was "Artificial Intelligence and Image Recognition".

He spoke on the combination neural network methodology. He started by mentioning the image recognition *CAPTCHA* that we encounter while trying to login or access a web resource. Going to the very fundamental of image recognition, he explained how the gradient descent method works and algorithmically a computer recognises a figure. This algorithm translates matrix data to a linear array and does the work.

The last technical session chair person was Mr. Subhaji Bose, Deputy Head, Department of Computer Science and Applications. He introduced Mr. Sandeep Sengupta, Managing Director, Indian School of Ethical Hacking (ISOEH), Kolkata.

Mr. Sengupta built on the National Science Day theme. He showed the following slide and asked students to understand how a future home / office is going to look like. This represents the devices/ appliances inter-connected in the home network. This is what we call as Internet of Things (IoT).



Then he mentioned that youngsters need to be ready for jobs that do not exist today. He spoke about Industry 4.0 which is presently going on. Then he went on to explain what the current job trends are and which industries youngsters are more likely to get jobs. One of them being in the area of Cyber security. He further mentioned that the government needs 500,000 trained professionals; but as of today there are only 70,000. He mentioned how important it was for new generation of students to choose a career in such field. And the salary is very high for candidates who can prove their skills! To help students, Salesian College has already partnered with ISOEH for industrial training of students. He encouraged students to make the best of the opportunities available.



Next presenter was Mr. Amit Singh, student of BCA, third semester. His topic being "Cyber Security Awareness" he explained why awareness was important. Some of the concepts he mentioned were:

- Technology cannot protect us from everything
- Hackers go where security is weakest
- Risk reduction
- Being aware and alert

- Medical data
- Computer resources

We could achieve these by:

- Keeping operating system, browsers, network system up-to-date with latest fixes/ patches
- Using proper anti-malware software
- Using proper password management tools
- Using two factor authentication

- device safety protocols
- internet safety protocols

Final presenter was Mr. Rahul Chettri, student, BCA third semester. His topic was "Artificial Intelligence". Starting from the use of drones in agriculture for spraying water or pesticides, AI is being used by companies for hiring staff, financial services, medical science, advertising and so on, Rahul took us through some of the key challenges and opportunities, gradually to the next level of future possibilities.



He took us to the conclusion:

"Artificial Intelligence is the product of both science and myth. The idea that machines could think and perform tasks just as humans do is thousands of years old. The cognitive truths expressed in AI and Machine Learning systems are not new either. It may be better to view these technologies as the implementation of powerful and long-established cognitive principles through engineering."

Having come to the end of technical sessions, we had our Vice Principal, Fr. Aju Kurian, with his final words of congratulations to all the speakers and organisers, and encouragement to the faculty and students of Science Departments to carry on with the good work.



"Community, Diversity & Egalitarianism in India Society"

Organised by Department of Political Science, Sociology, History in collaboration with IQAC of Salesian College Sonada – Siliguri.

The webinar started with the prayer by Fr. Rector (Dr.) Tomy Augustine by asking God's blessings and guidance on the seminar.

After the prayer by Father Rector Tomy, Mr Pawan Rai (HoD) Department of Political Science gave an introduction of Prof. Gail Omvedt who was a sociologist, a human right activist born in Minneapolis on 2nd of August 1941; a prolific writer and a thinker, who studied at Carleton College at UC Berkeley. She did her PhD on Cultural Revolt in a Colonial Society: The Non-Brahman Movement in Western India, 1873-1930 from Berkeley University in 1973. She came to India for the first time in 1963 as an English tutor in Fulbright Fellowship. Prof. Omvedt's contributions can be categorized into two, Academics and Social activism. In the field of Academics Prof. Omvedt wrote numerous books and articles, she wrote extensively on caste, class and gender. She was associated with many research projects she was also a consultant for Food and Agriculture Organisation (FAO), United Nations Development Program (UNDP), Oxfam Novib (NOVIB). She also served as Dr. Ambedkar Chair Professor at National Institute of Social work and Social Sciences (NISWASS) in Orissa. She was also a Professor of Sociology at the University of Pune and Asian Guest Professor at the Nordic Institute of Asian Studies, Copenhagen. She was also a Senior Fellow at Nehru Memorial Museum and Library and also a research Director at Krantivir Babuji Patankar Sanstha. As far as Social Activism is concerned Prof. Omvedt's contribution in Social Movement in India is immense, she was a powerful force in Dalit and anti-caste movement, environment movement and farmer's movement. She was the vanguard of rural women movement. She was active in Shramik Mukti Dal, Stri Mukti Sangarsh Chalval which works on issues of abandoned women in Sangli and Satara districts of southern Maharashtra, and the Shetkari Mahila Aghadi, which works on issues of women's land rights and political power.

Prof. Omvedt wrote extensively on caste, class and gender some of the remarkable works by her are Cultural Revolt in a Colonial Society: The NonBrahman Movement in Maharashtra (1966); We Shall Smash This Prison: Indian Women in Struggle (1979); Reinventing Revolution: New Social Movements in India (1993); Dalits And The Democratic Revolution: Dr. Ambedkar And The Dalit Movement In Colonial India (1994); Buddhism in India: Challenging Brahmanism and Caste (2003). For her outstanding contribution in the field of academics and social activism she was bestowed with numerous awards and fellowship some of the remarkable fellowship and awards are: Honorary Woodrow Wilson Fellowship (1964–65); Fulbright Fellowship as Tutor in English in India, (1963-1964); University of California Graduate Fellowships, (1964-65, 1965-66); American Institute of Indian Studies, Junior Fellowship for PhD research in India on "The Non-Brahman Movement in Maharashtra," (1971); American Association of University Women, Fellowship for research on "Women's Movement in India," (1975); Savitribai Phule Puraskar, Padmashri Kavivarya Narayan Surve Sarvajanik Vacanalay, Nashik, (2002); Dr. Ambedkar Chetna Award, Manaywadi Rachna Manch Punjab, August (2003); ABP Majha Sanman Purskar (2012); Matoshree Bhimabai Ambedkar Award (2012), Vitthal Ramji Shinde Award (2015); Lifetime Achievement Award from the Indian Sociological Society (2018).

After the introduction of Prof. Gail Omvedt by Mr Pawan Rai, Fr. Principal, Prof Dr George Thadathil gave a welcome address. He welcomed the spokesperson Dr. Bharat Patankar and all faculty members and students present in the webinar, while giving homage to Prof. Omvedt.

Mr Pawan Rai welcomed and gave an introduction of Dr. Bharat Patankar who was the spokesperson of this webinar. Dr. Bharat Patankar was born on 5 September 1949 in a village called Kasegoan, Dist. Sangli near Satara and Kolhapur in the Indian state of Maharashtra. He received his MD degree in Gynecology at Government Medical College, Miraj. He is a leading activist (co-founder and President) of the left wing of Shramik Mukti Dal. He was one of the founding members of Krantiba Phule Sanskritic Manch. He is a leading activist in the Badwe Hatao movement of Vidrohi Sanskritic Calval. Along with this he participated in numerous irrigation and dam movements in india along with social activism Dr. Patankar wrote numerous books and articles. Some of his outstanding works are: "Characteristics of Contemporary Caste System and its Annihilation" (2014), Maharashtrace Shilpakar Nana Patil (2002); Paryayi Vikas Niti (1991). For his outstanding contribution in the field of academics and social activism, he was conferred with numerous awards: Arun LImaye Yuva Jagar Puraskar of Chhatra Bharati; Samajik Krutadnyata Puraskar, Dalit Mitra Puraskar and Baburao Bagul Gaurav Puraskar Award.

After the introduction, Dr Patankar began his lecture by dedicating it to his life companion Prof. Gail Omvedt. He thanked the organizers for holding a memorial to honor her and her work.

Dr. Pathankar started his lecture by pointing out that "community, diversity and egalitarianism in India" were present in there in ancient India.

Matrilineal clans which were called gana-sangas or Matrilineal gana-sangas, were present around Indus valley civilization and these systems functioned according to the ideas of community, diversity and egalitarianism where we can see that there was no exploitation of any kind. These gana-sangas though were matrilineal in nature they were not matriarchal, they provided a field for the growth of an egalitarian society, and there was an absence of contradictions within the community which brought about a feeling of harmony. If there had been a presence of matriarchy then a quasi-state system would have been produced, which would have led to the disintegration of the totality of the community. In India we have the history of matrilineal gana-sangas that were prevalent in the north-east of India and to some extent in Kerala. As there was absence of privatization of property in these matrilineal societies, there arose no cases of enmity between the people. The people lived in complete harmony with his surrounding environment. As these societies were grounded on decentralization of power, there was absence of hierarchy between man and women. There was no question of exploitation regarding gender, class and caste. These matrilineal society gave a classic example of a society based on community, egalitarianism and diversity.

As years went by these matrilineal gana-sangas slowly got transformed into patriarchal gana-sangas. Dr. Pathankar pointed out here that we could still find egalitarianism in these patriarchal gana-sangas, as the concept of privatization had not entered the society. The change that took place between the relationship of man and women and the absence of egalitarianism within the family slowly started to affect the egalitarianism of the gana-sanga. Women is an essential part of the community and when there was exploitation of one part of the community by the other, the egalitarianism cease to exist in the community. So, when the gana-sanga changed from matrilineal to patriarchy, the spirit of egalitarianism also got eroded.

Talking about diversity, he showed that there was diversity in both matrilineal and patriarchal ganasanga. This diversity was neither hierarchical nor exploitative. The nature of this diversity depended on the qualities of a person and his ability and skills. So, this kind of diversity of the cultures and the diversity of the skills was there but without hierarchy. However, these aspects of the patriarchal gana-sangas started getting destroyed parallelly south of the Ganges and north, later on in the southern part of India some 600-700 years after the Sangam period. In south India we can see that these

egalitarian community continued much longer than in the north and remained in the eastern part for a longer time than in the south.

With the coming of kingship there was deterioration of the patriarchal gana-sangas. Buddha who was also living in the time of patriarchal gana-sangas tried to create an egalitarian community through his Buddhist sangas because it was absent in the society of that time. Buddha mainly tried to create an egalitarian community that was based on harmony and equality. He took many principles from the matrilineal and patriarchal gana-sangas. Dr. Pathankar pointed out that women were given entry into the Sanga when they came to Buddha and questioned him about the lack of women's participation in a sanga which was egalitarian in nature. From the verses of Therigatha, we know that there was an involvement of women equally along with the men in spiritual attainment and emerging new sangas kept the elements of community, diversity and egalitarianism. Though the existing society during the period had lost its egalitarian nature, the Buddhist and jain sangas therefore existed as islands which upheld the ideas of egalitarian diversity and community. After the sangas, we can only find some traces of these community in the tribal society in the mountainous regions, who rejected to join the society which has lost its egalitarian diversity and their sense of community cohesion. It can be seen that with the coming of globalization, the community systems held by the tribal people; the Adivasis as well as the eastern hill tribes has been affected. These recent changes have now brought us to a society that has lost its sense of community and egalitarian diversity.

Omvedt when she wrote her *Buddhism in India*, she was the first person to point out that for a thousand years from 600 BC to 600 AD there was an absence of caste system, there may have been existing forms of caste system which however where not discriminatory. It was those very thousand years that prevented caste system from getting established in India, but once the Buddhist monks were killed, the caste system started growing rapidly. One can take the example of Buddha's peaceful intervention into the dasa-shudra slavery which was existing in those days, which led to the abolition of slavery. Here, Buddha can be seen as a reformist who showed the possibility of bringing into practice a society which is based on egalitarian community, without the use of violence.

Through this observation we come towards a question about the needed reestablishment of an egalitarian community that values diversity and harmony amoung its members. This possibility of establishing such a community was Prof. Gail Omvedt's dream, as stated by Dr. Pathankar. This "dream" towards which Prof. Omvedt worked throughout her whole life was also the dream that was held by Buddha, Babasaheb Ambedkar, Phule and the saint poets like Kabir. Dr. Pathankar lucidly explained how Prof. Omvedt through her analysis has put forward the idea that theorists like Ambedkar and Phule

were also trying to reach an alternative society which is based on egalitarian ideals which protects the idea of the freedom of diversity.

Gail Omvedt's book "Seeking Begumpura", which is based on Saint Ravidas's poem; who imagined of an egalitarian society with diversity, which was also based on the idea of community cohesion. Prof. Omvedt wanted to show that "Begumpura" the city or country without "gum" or "dukkha" (sorrow) is possible even today. Through the analysis of Buddha's intervention in the dasa-shudra slavery we can see that this can only be possible with a unanimous decision of all people who have decided to change this society. This is a question of changing the exploitative system and is not a suggestion of a fight between one majority section and a minority. Dr. Pathankar clearly points out in his words that "it is a question of liberating everyone from the clutches of the existing systems and making everybody more humane." This was the dream which was bought forward by Buddha, saint poets and Ambedkar. This was also the view brought forward strongly by Gail in her book "Seeking Begumpura". The real homage we can give to Gail Omvedt is by seeking Begumpura and reinstating these three aspects of community, diversity and egalitarianism into the creation of a more humane society.

The lecture was followed by an interactive session of questionnaire which was very informative. The webinar helped the students and the faculty the know more about the works of Prof. Gail. Omvedt and it made conscious of our responsibility to the establishment of the egalitarian community with diversity.

The session ended with a very thoughtful vote of thanks from Mr Samip Sinchuri (HoD) Department of Sociology.
